## HUMAN RIGHTS – THE ROLE OF CIVIL SOCIETY ORGANISATIONS

### Concept

The respect for human rights and the defence of democracy are European core values that are presently being threatened with the rise of extremisms and far-right movements. Can Civil Society Organisations (CSOs) play a more active role to fight this trend? What are the most significant challenges they face within the European framework? What opportunities are being missed in addressing the needs of European citizens?

## **Objectives**

The International Conference "Human Rights: The Role of Civil Society Organisations" is an initiative of the Active Citizens Fund in Portugal in partnership with Fund Operators from Poland and Bulgaria. Drawing on different experiences in these three countries, the conference aims to raise awareness on the critical role that CSOs can play in reinforcing the promotion of human rights and tolerance, in fighting discrimination on the grounds of racial or ethnic origin and in supporting political action in favour of human rights.

As promotion of Human Rights is one of the main areas of support of the Active Citizens Fund, the Conference is also an occasion for NGOs to share experiences and good practices in order to prepare and submit to the Fund more innovative and effective projects in this area.

#### **Participants**

Speakers include representatives from the Fundamental Rights Agency, the Active Citizens Fund Operators and NGOs in Poland, Bulgaria and Portugal. The Conference will address primarily Civil Society Organisations but it is open to academia and the general public. All Active Citizens Fund Operators shall be invited to participate. A specific individual promotion will target CSOs. 100-150 participants are expected to attend.
